POSITION: Assistant/Associate Professor in Sport Management. This is nine-month tenure-track position.

The Department of Exercise, Sport, and Leisure Studies prepares scholars, practitioners, and leaders in exercise, sport, and recreation by conducting cutting-edge research and maintaining a commitment to inclusive excellence, social justice, and global initiatives. Program areas within the Department are Sport Management, Recreation and Leisure Studies, Sport Studies, and Exercise Science.

Students in the Sport Management program at the University of Tennessee are offered the opportunity to develop the skills and knowledge necessary for a career in the sports industry. Undergraduate students earn a major in Sport Management with a minor in Business. A concentration in Sport Management, as well as a dual MS/MBA degree offered in conjunction with the College of Business Administration, is available at the master's level. A doctoral specialization in Sport Management is also available.

REQUIRED QUALIFICATIONS:

- An earned doctorate or appropriate terminal degree in sport management or related field.
- Evidence of scholarly achievements in area of expertise.
- Ability to direct theses and dissertations.

PREFERRED/DESIRED QUALIFICATIONS:

- University/college teaching experience.

RESPONSIBILITIES:

- Teach in the area of Sport Marketing at the graduate and undergraduate level.
- Conduct quality research leading to publication in scholarly, refereed journals.
- Participate in professional, university, and community service.
- Advise and mentor graduate and undergraduate students.

SALARY: Competitive and commensurate with experience. Possible opportunity to teach during summer term.

APPLICATION PROCESS: Review of applicants will begin September 1, 2009 and will continue until position is filled. Position effective January or August 2010, dependent on completion of the search. Interested persons should submit a letter of interest addressing their credentials as they relate to the position along with a copy of their vita, and the names and contact information (mailing address, phone number, e-mail address) of three reference persons.
