

FALL/SPRING CAMPUS DINING CONTRACT TERMS AND CONDITIONS

A. The student agrees that if attending the University of Tennessee and a meal plan is selected, he/she will (if applicable) take meals in the dining facilities for the entire period of the contract. UT Campus Dining, under this contract, will provide either the Meal Plan or Dining Dollars plan the student has selected. **(Please note: Meal plan contract meals do not include Saturday dinner meal. Dining Dollars may be used to purchase this meal.)**

B. At the beginning of each term, the first meal served will be breakfast on the first day of final registration for classes for that term (the Monday on or before when classes begin). The last meal served for the term will be the evening meal of the last day of final exams for that term.

C. Meal plan contract covers the entire academic year! (Fall and Spring Semesters)

Meal plan is not valid between semesters and during Spring Break. Dining Dollars will roll over from Fall to Spring semesters provided the student remains enrolled at the University, does not change to a Varsity Inn meal plan and continues to reside in University Housing. Dining Dollars are forfeited if the student leaves the University or moves out of University Housing. Unused Dining Dollars expire at the end of the Spring semester.

D. Vol-Block meals will roll over from Fall to Spring semester provided the student remains on the Vol-Block plan. If a student changes from a Vol-Block plan to another meal plan, any unused Vol-Block meals are forfeited. Commuter block plans (Commuter 50 and Commuter 75) will roll over if the student remains on the same Commuter block plan. Changing to a different block plan will result in any unused meals being forfeited. Students changing from a Commuter block plan to a Commuter Dining Dollar plan or from a Commuter Dining Dollar plan to a Commuter block plan will forfeit any unused Dining Dollars.

E. Refunds will not be given for meals missed due to academic scheduling problems or trips taken by the resident for academic or extracurricular purposes. For periods of sickness or hospitalization, a refund will be granted for only those meals missed in excess of 15 consecutive meals with medical verification.

F. Whenever possible, UT Campus Dining will assist students having special dietary needs upon receipt of a letter or dietary plan from the student's physician. Refunds or reduced rates cannot be made because of special dietary requirements.

G. The student assumes responsibility for assuring meal plan validation each term. Failure to pay fees or use the meal plan does not constitute a release from the dining portion of the Housing/Dining contract with the university.

H. UT Campus Dining reserves the right to control the use of meal plans within campus dining facilities.

I. Meal Plans and Dining Dollars cannot be shared or transferred to another student.

J. Students that live in University Housing may not sign up for any of the Commuter meal plans. Off-campus students who contract for a Commuter plan and subsequently move into University Housing and do not select a meal plan must forfeit any remaining Commuter meals and Dining Dollars. Off-campus students who subsequently move into University Housing and do select a meal plan may contact the Dining Services office and ask that their previous Dining Dollar balance be transferred over to their on-campus meal plan.

K. Students that live in selected fraternity housing may qualify for tax exemption status.

L. Commuter Dining Dollars and the Commuter Meal Plans (Commuter 50 and Commuter 75) may only be purchased by off-campus students. UT Campus Dining will verify that students who sign up for these meal plans do not live in University Housing.

M. The Apartment Any 8, Apartment Any 5 and Apartment Dining Dollars plans may be purchased by the residents of Andy Holt Apartments, Laurel Apartment, Vol Hall Apartments and Sutherland Village. Off-campus students may also purchase these plans (sales tax will be added).

N. All off-campus students that sign up for meal plans must pay applicable state and local sales tax.

O. Students that move from University Housing to an off-campus residence forfeit any unused meals and Dining Dollars.

P. Students that are released from their Housing/Dining contract will be refunded the unused meals portion of their meal plan based on the Housing/Dining refund schedule and the unused Dining Dollars based on the amount spent.
